<b>Recommendation:</b>	That the report from Dianne Nemeth, Returning Officer on the Disclosure of the By-Election Campaign Disclosure and Finance Statement, as required under the Local Authorities Elections Act, be received as information and filed.

**Purpose:** The Local Authorities Election Act, Section 147.4, requires candidates to file a declaration in the prescribed form by June 1, 2011 outlining their total amount of campaign contributions and expenses. The Act requires candidates to disclose all contributions listing separately any contributions greater than \$100, and any other funding sources and expenses. Any surpluses over \$500 from the campaigns are to be given to the City to be held in trust until the next general Municipal Election. The Act states that candidates that are self funded, spending less than \$10,000, are not required to submit or complete a Disclosure Statement.

**Background:** All of the candidates in the By-Election have filed the required declarations. The filed Campaign Disclosure and Financial Statements, Provincial Form 21, are available for viewing at the Office of the City Clerk and on the City website. None of the candidates reported surpluses.
