

BYLAW 6215

A BYLAW OF THE CITY OF LETHBRIDGE TO AMEND
BYLAW 5651 – PARKS BYLAW

THE COUNCIL OF THE CITY OF LETHBRIDGE, IN THE PROVINCE OF ALBERTA,
DULY ASSEMBLED, HEREBY ENACTS AS FOLLOWS:

1. Bylaw 5651 – Parks Bylaw is hereby amended as follows:

(a) the following is added after s. 1(f):

“(f.1) “Cemetery” means land within the City that is set apart or used as a place for the memorialization of human remains.”;

(b) the following is added after s.1(q)vi:

“vii. Means any cemetery.”;

(c) the following is added after s. 8(d):

“(e) Operate any Watercraft in a Cemetery.”;

(d) the following is added after s. 11:

“11.1 The City Manager may make policies, procedures and rules regarding the administration and operation of Cemeteries, including but not limited to:

(a) subdivision of cemeteries;

(b) burials, interments, inurnments, and disinterment of human remains;

(c) burial alternatives and options;

(d) exchanges of burial rights;

(e) monuments;

(f) operations and maintenance standards.”;

(e) the following is added after the first paragraph in s. 22:

“Any person receiving services at a Cemetery shall pay the fees and charges as set out in Schedule “B” Fees and Charges.”;

(f) the following is added after s. 30(d):

“(e) Notwithstanding subsection (a), no person shall ice fish or ice skate, on a water body in a Cemetery.”

(g) the attached Schedule “A” is added to the end of Bylaw 5651 as “Schedule “B” Fees and Charges”.

2. Bylaw 5004 is hereby repealed.

3. This Bylaw shall come into full force and effect on the date of final passing.
