The above charges are applicable to all consumers whether or not any consumption of water is metered during the billing period.

NON-FROST PROTECTED METER CHARGE

In addition to all other applicable charges, a daily Non-Frost Protected Meter charge of \$0.83 per day will be levied to facilitate the necessary seasonal removal and reinstallation of any meter that is not in compliance with Clause 18 (b).

FIRE PROTECTION SERVICE CONNECTION CHARGE  
Based on Service Connection Size

For each service connection eligible under Clause 13(c) the daily service charge shall be based in the size of the first connection dedicated solely to fire protection.

A daily Fire Service Charge of \$0.13 per day applies to each private fire hydrant not supplied water from a 13(c) fire service connection or a metered connection.”

WATER CONSUMPTION CHARGES

Domestic Water Consumption Charge

All domestic consumption of water shall be charged at a rate of **\$1.275** per cubic metre.

Commercial Water Consumption Charge

<u>Monthly Consumption</u> <u>(Cubic Metres)</u>		<u>Rate per Cubic Metre</u> <u>(Cumulative)</u>
From 0	to 750	\$1.124
From 751	to 25,000	\$0.784
From 25,001	to 50,000	\$0.674
From 50,001	and upwards	\$0.511

Irrigation Water Consumption Charge

All consumption of water registered on a lawn service meter (Section 36) shall be charged at a rate of **\$1.330** per cubic metre.

Regional Water Consumption Charges

All consumers located outside the legal boundaries of the City shall pay Commercial Water Consumption Charge and are subject to an additional Water Transmission Capital Surcharge of **\$ 0.023** per cubic metre."
