 - General Discussion.
- Commission Members' Questions
 - Would athlete records continue to be recorded through national international platforms such as BoxRec and Combat Registry, rather than a provincial platform which would create redundancy in the registration process?
 - Key members of Government of AB are focused on red tape reduction, and are dedicated to ensuring that registration does not fall through the cracks.
 - Would there still be regional representation in a Commission capacity for combative sporting events in the province, and what are the general plans for a fee structure in the smaller Alberta communities?
 - Consistent feedback thus far shows regional representation is key. Representatives look forward to continuing to support events regionally, including communities the size of Lethbridge and smaller. If a fee structure is included in the updated legislation, representatives will ensure that the fee structure will not deter new and continuing athletes and promoters.
 - Would there be a change in the structure of our regional commissions?
 - Representatives have yet to make a final decision on a recommended structure, should a Provincial Commission be voted into legislation. In the case where a Provincial Commission comes into place, the goal of representatives would be to have as little disruption to currently conducted business as possible, including venues currently booked and events currently sanctioned under the standing commission structure.
 - An official position of the Lethbridge Combative Sports Commission has not yet been requested. Have other Alberta commissions made their position on a Provincial Commission clear?

- At this time all other commissions have expressed a position of in favour with exceptions/ recommendations to the proposed governance and operations of a Provincial Commission.
- Has an autopsy and investigation concluded for the latest combative sport fatality in Alberta?
 - This fatality is still currently under investigation. Legislation recommendations will likely be released before a conclusion to the fatality investigation is complete.
- Concern expressed with the recommendation of concussion protocol spotters located in the crowd. Subject matter experts recommend if these spotters are required by legislation they be stationed at ringside in order to closely observe athlete safety.
- Recommended that the responsibility of athlete safety be evenly distributed amongst commissions, athletes, coaches, promoters and officials.
- Review Progress & Next Steps
 - Any requested responses to the Tim Hague Fatality Inquiry Recommendations are to be submitted by March 5, 2025.
