- In buildings to be demolished, materials having the potential for releasing asbestos fibres shall be removed prior to demolition.
- Prior to any demolition work, the structure shall be inspected for the presence of asbestos. Should asbestos be present, the owner/contractor shall have the asbestos removed by a qualified abatement specialist and provide documentation to confirm completion of abatement.
- The Alberta Asbestos Abatement Manual (AAAM) is the Provincial Guideline for survey and abatement protocols.
- Asbestos abatement requirements are located in the Occupational Health and Safety (OHS) Code administered by Workplace Health and Safety. Occupational Health and Safety legislation requires that Workplace Health and Safety be notified at least 72 hours before asbestos abatement commences.
- Construction debris dumped in other than approved landfill sites will require approval of Alberta Environment at 403-381-5322.
- It is the responsibility of the owner/contractor to have all utilities disconnected prior to demolition.
