RE: NOTICE OF HEARING - SUBDIVISION AND DEVELOPMENT APPEAL BOARD

An appeal has been filed against the Development Permit approved by the Development Officer on November 28, 2023 for a fence height waiver at 250 McMaster Boulevard West.

I begin by thanking the members of the Development Appeal Board for their service. I recognize that it is a difficult task with much material to wade through.

I am, in the strongest terms possible, against extending a waiver for a fence in the front yard for the daycare business at 250 McMaster Blvd.

Following are my reasons for opposing the granting of this waiver:

1. It can reasonably be assumed that the fencing being applied for is to facilitate the business adding more children in that new fenced space or to spread out the children currently enrolled. This increased space will also open the door to the daycare being able to grow to a child care major classification. This daycare business was approved June 21, 2019 (Enc. 1) despite the expressed, firm opposition by more than 150 people in the neighbourhood. The opposition primarily focused on the safety of adding additional traffic on an already busy pedestrian and vehicular route. McMaster Blvd. was identified by the City traffic department, specifically by Mr. Ali, to be a super collector, using traffic count numbers from 2016. The 2019 census shows a 7.8% increase in the West population from 2016 to 2019 and a further 7% increase from 2019 to 2023. (Enc. 2) The traffic department failed to take into consideration this increase in traffic when supporting the original daycare application. I have called Mr. Ali to ask for

the most recent traffic count numbers for McMaster and Temple but have not received a call back at the time of this writing. In the absence of data, those of us who live in the neighbourhood can assure you that traffic has increased exponentially since the 2016 traffic count. We see clients of the daycare pulling into the loading zone and then backing out into the busy traffic on McMaster. If more children are added there will be more traffic.

2. Parking was also a concern expressed by those opposed to the 2019 application. The Business indicated that 100% of their parking will happen on their property, or the designated loading zone in front of their property. (Enc. 3) This has proven to not be the case. In the Development Appeal Committee meeting in June of 2019 the applicant changed their parking statement to say that their staff would park at the parking lot in Nicholas Sheran Park or be walking or ride sharing. Bylaw 6300 required them to have 9 on-site parking spaces, however, they were granted a waiver of 5 off street parking spaces (more than half of the requirement), thereby requiring 4 off street parking spaces, 2 of which were to be signed and designated for loading/unloading spaces, which means there are only 2 off street parking spaces for staff and 2 for loading/unloading. That puts as many as 7 staff vehicles parking on McMaster Blvd which impedes the view of the park for the resident to the immediate north of the daycare Business. It is not uncommon to see three vehicles parked side by side in the loading/unloading zone and other vehicles waiting on the west side of McMaster.

If the designation moves to child care major, more staff will be required and therefore, more parking on McMaster. People on McMaster made their purchasing decision based on the proximity and view of the park. This has been taken away from them and will only be exacerbated if a fence goes up and more children are enrolled, which means additional staff.

3. The 2019 Development Appeal Board took the opinion that the “additional traffic, noise, and parking do not present undue interference with the neighbourhood amenities and would not materially interfere with or affect the use, enjoyment or value of neighbouring properties. (Enc. 1)

This statement has proven to be patently untrue. There is most certainly additional traffic and the parking by the staff and parents is not reasonable. The approval of a waiver of more than half the parking required under Bylaw 6300 is evidence of the unreasonableness of parking.

Most certainly the noise has significantly presented undue interference with the use and enjoyment of our property and that of the property to the immediate north. The sound of the children playing in the yard was described as joyful and melodic. To the contrary, when the children are outside the sounds are screaming and screeching to the point that during the months when we would normally be enjoying our back yard, the screaming and screeching is so loud that we cannot hold a conversation and have had to retreat to the front yard or inside to even be heard. The applicant has built a pergola and deck in the back yard that is immediately adjacent to our fence. The deck has some kind of harness apparatus. (Enc. 4) Yes, this does generate significant noise. Last week, in addition to the usual screaming and screeching, children were loading rocks into buckets and dropping the rocks down the slide. Be assured that the resulting clatter was not the melodic, joyful sound of children playing. It was a very jarring, irritating noise. A new play area in the front will now render our entire outdoor property unusable when the children are outside. Further to the noise issue, it is not uncommon that the screaming and screeching noise is loud enough that it is a disturbance even when we are inside our home behind closed doors. Please do not be overly influenced by the notion that this is a daycare and daycare spaces are needed. That is an unarguable fact. But also, be aware that there are no less than six childcare centres within a 10-minute walk of this property, in addition to family day homes. I suggest that this neighbourhood is at its saturation point for daycares, especially when considering that the growth on the West side is further to the west and not in this neighbourhood. A 3 meter fence provides no noise abatement.

4. The Planning and Design office has indicated to the applicant that no waiver is required for the proposed 2 meter fence on the west side of their property. This fence is in my front yard and the Land Use Bylaw restricts fence height in a front yard to 1 meter. I have tried to have this error corrected by the Planning and Design office to no avail. In fact, Ms. Gehring

told me to walk over to 2 and 6 Eton Road and I would see that they are the same as our situation. She could not be more wrong. There is an alley between those two properties and neither has a 2 meter fence in the front yard of a neighbouring property. Ms. Olsen, Ms. Tittsworth and Ms. Gehring from the Planning and Design office are insisting that the proposed fence on the west in the rendering is the applicant's side yard and therefore a 2 meter fence is allowed. In considering the site drawing distributed with the "Notice to Neighbours" (Enc. 5) and comparing it to Bylaw 6300 as it pertains to fences (Enc. 6), you can see that the two renderings are not similar due to the pie shape of the two adjoining properties on McMaster and Temple. When I attended at the Planning and Design office to get clarification, I was told that the applicant could build a 2 meter fence on the west side of the property since it was their side yard yet if I wanted to build a fence on the same line it could be only 1 meter since it was my front yard. Does that not strike you as absolutely the height of bureaucratic ridiculousness? It also reeks of imbalanced support for the daycare at my expense?

5. The City's Design Standards provide designers with clear direction about the vision of building and maintaining a(n)attractive . . . city." The installation of a 2 meter fence in any portion of the applicant's front yard or my front yard does not speak to maintaining an attractive city. It will be inconsistent with the neighbourhood along McMaster and Temple and will be an eyesore. The proposed 2 meter fence on my front yard and the 2 meter Temple fence will obstruct the view of Nicholas Sheran Park from my property. Ms. Gehring said that we can't see the park from our front yard now because our garage is in the way. She is mistaken. In the rendering provided by Planning and Design (Enc. 5) you can see the white line from the garage to our east property line and can observe that the garage does not block the sight line to the park which will most certainly be obstructed if the applicant is allowed to install a 2 meter fence in my front yard.
6. It is deeply troubling and frustrating that the applicant is seeking another waiver that will yet again negatively impact the ambience and style of the neighbourhood and will interfere, in a significant way, with the peaceful enjoyment of my property. I feel confident, based on experience with this business, that there will be no peaceful enjoyment of my property. I remind

you that this daycare Business is in a low density residential area. Child care minor is a discretionary use but I firmly believe that approving a daycare and then allowing significant waivers to the Bylaw is unreasonable and an affront to those negatively impacted.

I recognize that Bylaw 6300 is under review; however, the sections related to fences is not being reviewed until 2025. This will be too late for the appeal and the damage will have been done and irreversible.

I would also like to point out that Angie Olsen approved an increase from 30 children to 50 children at the 6 avenue daycare operated by these same applicants, citing consistent use. Further, the newly established daycare at 1 Dalhousie was originally for 34 children, 6 staff and a fence height waiver for the "short" front and side yards to allow a 7'6" fence height. The Development Officer approved the permit in June. In July there was an application to increase to 50 children and was approved by MPC in August. There were no appeals received. To me, these two examples of expanding the numbers of children in daycares is very troubling.

Again, I respectfully urge you to deny the requested waiver for a 2 meter fence in the front yard at 250 McMaster.

SUBDIVISION AND DEVELOPMENT APPEAL BOARD DECISION

June 21, 2019

Re: Appeal of Development Permit No. 110773
Appellant: Edward Grant
Land Use: Low Density Residential (R-L)

Upon hearing representation made by the Development Officer, the Applicant, the Appellants, and other interested parties on Thursday, June 20 2019, it is the decision of the Subdivision and Development Appeal Board that the appeal is **DENIED** and the decision of the Municipal Planning Commission regarding Development Permit DEV110773 on May 7, 2019 to allow the establishment of a childcare minor with 50 children and 9 staff members at 250 McMaster Boulevard West is hereby **CONFIRMED**.

REASONS FOR DECISION:

1. The traffic counts at Temple Boulevard and McMaster Boulevard West show there are low volumes in 2016 compared to other super collector roads in the City.
2. The proposed development will not significantly change the traffic count and flow.
3. The parking waiver is reasonable considering the number of available parking spaces on public roads.
4. The Board is of the opinion that the additional traffic, noise, and parking do not present undue interference with the neighbourhood amenities and would not materially interfere with or affect the use, enjoyment or value of neighbouring properties.

Note: It is recommended that a traffic count and analysis be done at the intersection of Temple Boulevard and McMaster Boulevard West in the Fall to determine if any upgrade to the signal is required.

An appeal against this decision may be made to the Alberta Court of Appeal on a question of law or jurisdiction only. Should you wish to do so, it is recommended that you retain legal counsel.

Hello, we are looking at opening an Early Childhood Education program at 250 McMaster Blvd West. We currently run Where The Wild Things Grow Early Learning Centre Ltd. in South Lethbridge. Our hours will be 7:00 a.m. to 5:30 p.m. We are closed all weekends, statutory holidays, and for over a week at Christmas. We will have 9 staff who will all park on our property. There will also be a designated loading zone for parents to drop off and pick up their children. We carpool at our current centre to create more parent parking, and to create less traffic. We have a great relationship with our current neighbours and hope to have the same here.

Common Concerns:

Traffic: McMaster Blvd and Temple Blvd are both collector roads, meaning they are capable and built to hold more traffic than other local roads. Parents drop off anywhere between 7:00 a.m. and 12:30 p.m., so it very staggered. Some parents walk or use public transportation cutting down on vehicles. Many families have multiple children that they drop off at once. Many parents or grandparents also keep children home for a day a week to spend extra time with them. At our current centre our capacity is 50, but most days we have a maximum of 42 children.

* **Parking:** 100% of our parking will happen on our property, or the designated loading zone in front of our property.

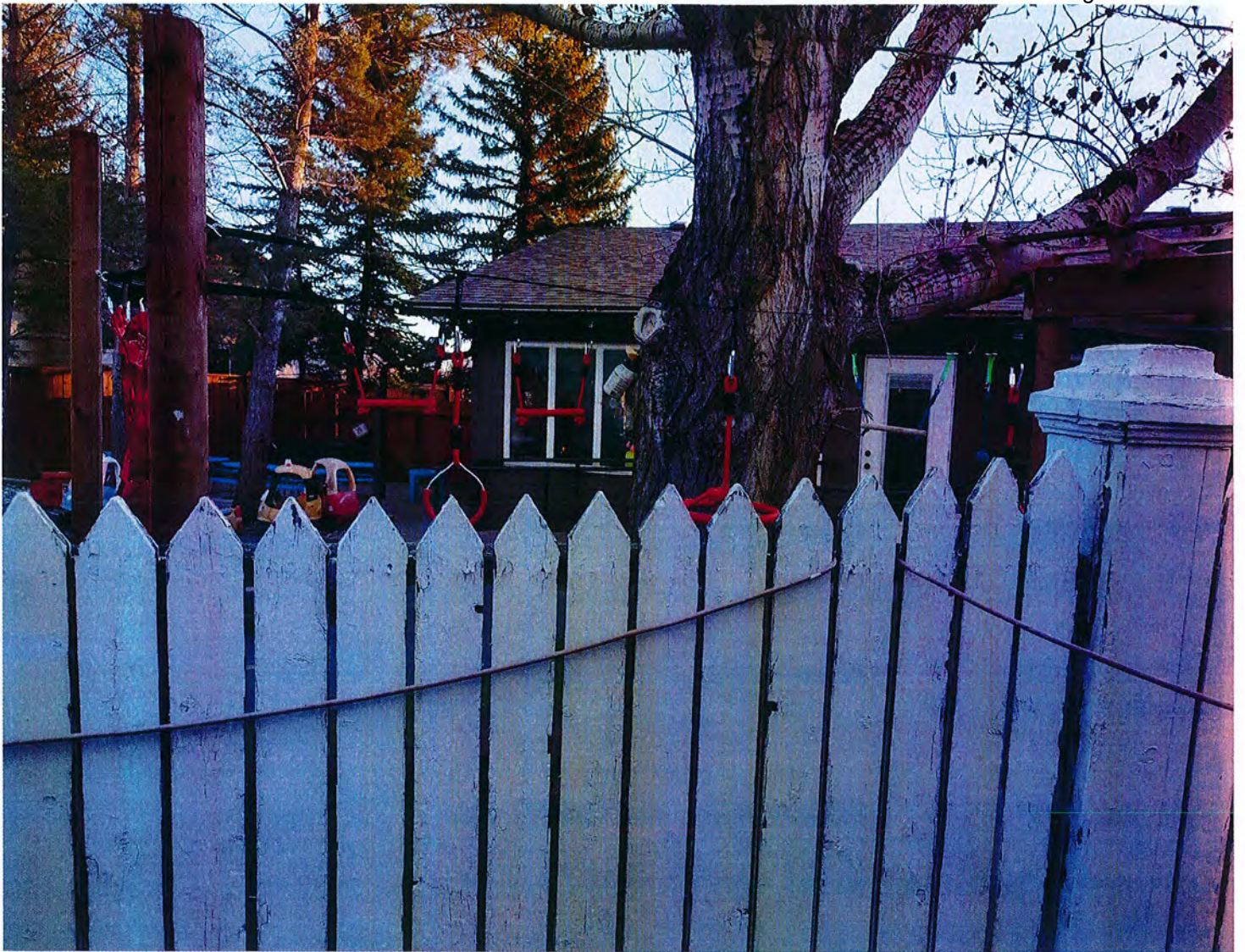
Noise: We will not go outside until 9:00 a.m. at the absolute earliest. We will be utilizing Nicholas Sheran Park as much as possible with weather permitting. Our current neighbours have said they have never heard us indoors, and often don't notice us in the backyard.

Yard Maintenance: If it snows over the holidays or on weekends we come in and maintain the sidewalks and driveway. We try our best to blend in with the neighbourhood, and keep our lawn and gardens well maintained.

We believe children are a valuable and important part of our community who do best in home like settings. West Lethbridge is booming, and in desperate need of quality child care. We hope to provide families in this area with the quality care needed. Kinder-care has recently been discontinued in the local schools, so we hope to walk the children to and from school and help fill this needed service in the community.

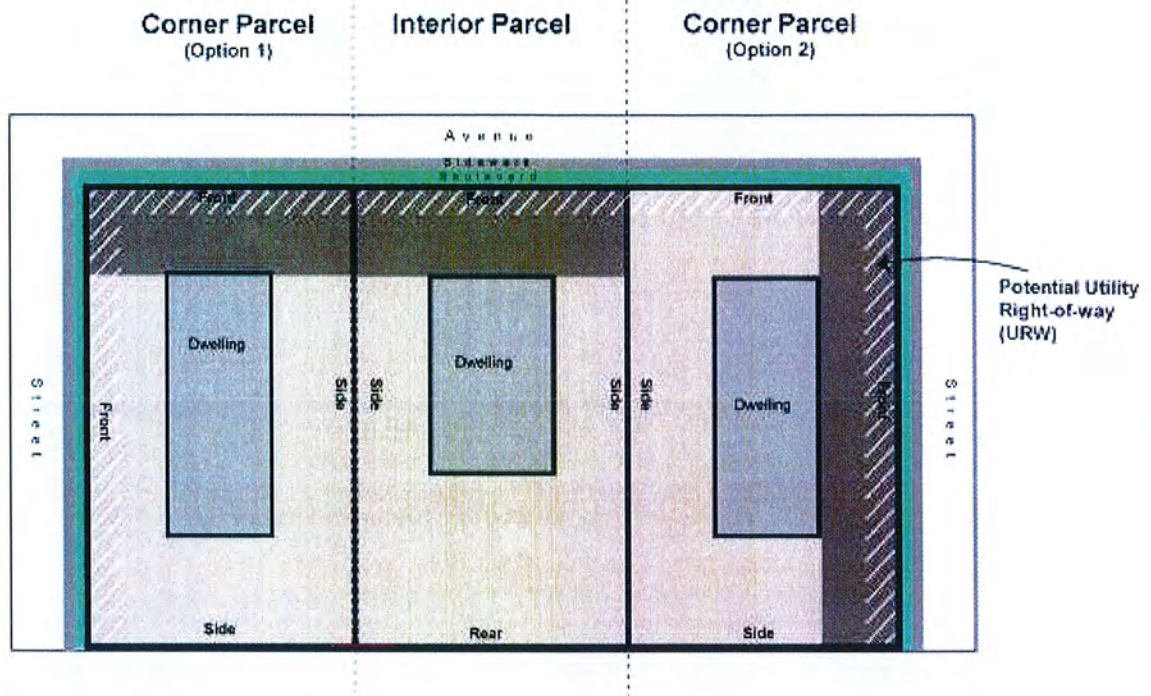

RE: 250 McMaster Blvd. West. Waiver for fence height in front yard

Subdivision and Development Appeal Board,

I reside in the home immediately to the west of 250 McMaster Blvd West.

I am a retired Police Officer who has training and experience with accident investigation and reconstruction.

As we take a larger look at the intersection of McMaster Blvd W and Temple Blvd W, there are some notable points to consider.

The street traffic flow was upgraded by the City Traffic Division when the daycare received a waiver and was approved to locate at 250 McMaster Blvd West. McMaster traffic allowing up to 15,000 vehicles per day and Temple Blvd up to 8,000 vehicles per day. Both streets are major traffic arteries. If that has changed, we were never notified. Last full traffic study was 2016.

The overhead crosswalk signal was removed from McMaster Blvd W, and a three way stop added. This remains a busy access for pedestrian and cycle traffic to and from Nicholas Sheran Park, and the elementary school.

Both the northwest and southwest corners of the intersection are stocked with the orange scooters and bicycles for the summer and mild seasons. This causes not only a distraction but also some visual obstruction. There is a high usage of these bicycles and scooters in the neighborhood.

With the school located north on McMaster and the Park on the east of McMaster, there is high pedestrian traffic. There is no reported pedestrian count from the City of Lethbridge.

The daycare clients have added to the traffic flow at this intersection. Numerous daycare clients fail to use the drop off / loading zone at the front driveway of 250 McMaster Blvd W; and pull around the corner onto Temple Blvd W, causing a distraction to other drivers and blocking the view for others while unloading and loading their children. The excess pedestrian traffic on the grass boulevard of Temple Blvd has caused severe damage to the grass, all by daycare clients loading and unloading their children.

The proposed Waiver to add a two meter fence to the fourth yard of 250 McMaster Blvd will add more restrictive sight problems to the current flow for vehicle, pedestrian, wildlife, bicycle, and scooter traffic.

The reduced line of site endangers and allows less reaction time for those maneuvering through this area and intersection. Protecting even one person is worth keeping the full line of site as open as possible.

The bylaw allows a city corner property to designate one of the two Street facing yards to be a side yard. The fourth side is allowed a one meter high fence.

Because a bylaw Waiver is requested, it does not mean the Waiver must be approved.

How many of the City Development Officers or Traffic Department employees have attended to and walked the area in question? Who has looked from the physical viewpoints and points of view of all those affected? Firsthand knowledge is most accurate.

With a one meter fence in the east yard of McMaster Blvd, all traffic would have a better, more full line of sight, giving everyone using the intersection a safer environment. With a high number of cars entering and backing out of the daycare, restricting any of the line of site will only add to the risk of accidents.

A second concern is the added, enlarged outdoor play area for the daycare on the south of their building that will increase the uncontrolled noise from the daycare.

City staff and the daycare have suggested the noise from the daycare children does not affect the neighbors. In fact, both have claimed the Supreme Court of Canada has ruled on daycare noise. That ruling has never been presented in fact and seems to be a rumor. If the ruling exists, please provide a copy of that ruling.

To those who determined the "melodic sound of children playing", 'would not affect neighbors' peaceful enjoyment and use of their own property were wrong. The attempt to see into the future and identify the screaming, screeching, and yelling we are subjected to was not addressed realistically or accurately.

The daycare originally suggested most residents in the community are away from their homes during the operating hours of the daycare. In this case both immediate neighbors are retired and are at home during the day. In fact, most local neighbors are retired individuals and are home most all day during the daycare operating hours. This was a poor inaccurate assumption on the part of the daycare. That fact has since been ignored by the City of Lethbridge and the daycare.

Expanding the two meter fence into the east yard and fourth side of the 250 McMaster property will increase the volume of noise from more children screaming, yelling, and screeching next to our front yard. We have lost the peaceful use of our back yard, now we will lose the peaceful use of all our yards while the daycare is in operation. What is right about that?

With our doors and windows closed, when children occupy the play areas of the daycare, the noise can be heard inside our home. We are forced to live with that constant excessive noise.

The daycare has no control over the children's noise or the affect it has on the neighbors, but we cannot enjoy our property because of the noise created by the children and staff of the daycare.

The daycare earns money, the city collects more taxes, and the neighbors pay the price of having to endure the uncontrolled noise, unable to enjoy their property during daycare business hours, in our low density residential area. All because the daycare can apply for waivers. The City Development Office can grant the waiver.

Our lives have 2,000 hours of excessive noise forced on us from the daycare every year. How are we compensated? Our concerns are dismissed, and we are ignored.

The daycare is catered to and granted exceptions and Waiver after Waiver to our detriment.

Does this City not serve residents of Lethbridge? As a Peace Officer I served to protect the public. The Lethbridge Development Office appears to serve the daycare rather than the general public. With the City Development Offices generous approval of numerous Waivers, why do we have bylaws when the bylaws seem to be disregarded and exceptions repeatedly allowed.

The intimate relationship which has existed between this daycare and Angela Olsen of the City Development Office and Mr. Ali of the City Traffic Department suggests concerns of a conflict and/or serious favoritism when dealing with the daycare Waiver requests.

Major Concerns:

Public Safety. Reducing line of site is dangerous for pedestrians, cyclists, scooter riders, and motorists on the street and exiting private driveways. (i.e.: 250 McMaster Blvd W loading zone)

Increased Noise. The excess uncontrolled noise with the expanded play area, multiplied, if the additional 2 meter fence is allowed.

Future Waivers. With the possibility of three designated play areas at this daycare location, will there be an increase of more children? (More Uncontrollable Noise / More Traffic)

APPEALS

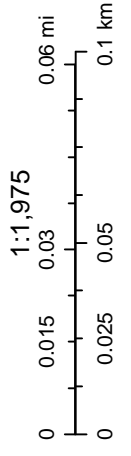

- The application was circulated to the City's Transportation Engineer and Traffic Engineer and Transportation Planning department on October 20, 2023.
- Comments received back from the Transportation Engineer on November 8, 2023, stated: "We did a sight line analysis and see no issues."
- Neighbourhood Notification letters were sent to residents within a 60 m radius of the subject parcel on November 9, 2023 with the comment period ending November 23, 2023.
- The Neighbourhood Notification letters highlighted the section of fence subject to the waiver (highlighted in red). The areas highlighted in purple and green, indicated fencing that did not require permits, as per the fence requirements of Land Use Bylaw 6300.

- Following the Neighbourhood Notification letters two written letters were received opposing the fence, with reasons provided including: concerns over screaming children, opposition to the original application for the day care, felt the fence would be an eyesore, felt there were no other similar fences in the area, their view of the park would be impeded, the existing daycare has impacted their use, enjoyment and value of their property, the subject property is in close proximity to a park, concerns over intersection safety and congestion, concerns over a nearby bus stop, concerns over scooters being left in the area.
- Following the Neighbourhood Notification letters, two verbal comments were received, both by phone and at the front counter, indicating a disagreement with the interpretation of Land Use Bylaw 6300 prescribed fence requirements.

It is situated near both our home and our in-laws place making it a short drive or even walk for us or the grandparents to drop our kids off and pick them up. I feel that this speaks to them going the extra mile to ensure that they do right by the children and families in their care.
- 2) I love that the Program utilizes the nearby parks and encourage the continued use, however if children can remain on the premises and still get the benefits of outdoor play especially in colder weather, why would we encourage the Program to take them across the street unnecessarily when they can use the play yards daily and the park when the weather is nicer. This way cold children can quickly be moved inside instead of having to walk back from the park. In the appeal the neighbours speak about the traffic in the neighbourhood and I would argue that if it is as bad as they are claiming then why should we expect small kids to regularly be crossing a busy intersection to enjoy time outside when they can just go into the backyard. I know as a parent I would be much more comfortable knowing my kid can safely enjoy time outside without the staff needing to walk them to the park.

If a person wishes to live in a neighbourhood without children there are adult only communities located throughout Lethbridge. This location is less than half a block from an elementary school and directly across from the busiest park on the west side. Both these things have been creating traffic and noise for many years. I (Ariel) attended Children of St. Marthas as a child and grew up in a house just a few blocks from here so I know firsthand how busy that area is and has been long before Where The Wild Things Grow West opened its doors.

Furthermore much of the appeal is focused on noise complaints and parking which I fail to understand the correlation between these things and having a taller than average fence built. - 3) A 6ft fence would limit toys or balls from going into traffic since children have more of a challenge practicing their throwing skills over a 6ft fence than a 3ft fence.
- 4) The extension gives the Program more flexibility in how they can safely maneuver children to the advantage of the neighbourhood. The 6ft extension in the front would mean that the older group that can have 20 children can be split up to limit noise or moved into another yard away from neighbour's back yards during the day.
- 5) It also means that neighbourhood noise could diminish with having a safe, accessible yard for each age group to be in, the one yard that they currently have now will not have to stagger groups throughout the day so that all children can play outside. They can use multiple yards at once and give the children what they need to develop and be apart of the community.
- 6) Outdoor play reduced stress 4 times more effectively than indoor play. There are numerous studies and articles on why outdoor play is crucial for children when they are in their formative years. Many young children are being forced inside where they are not allowed as many big motor movements, and I want my child to have the best possible chances at developing during these years.
- 7) Extending the fence does not mean an increase in children attending the facility but gives my child more room and spaces to grow and develop their skills.
- 8) The current appeal of this extension of the fencing height is based on the premise that it will lead to an increase in childcare numbers and more noise. The intention of this change in fencing height is to increase safety for the children who already attend this wonderful facility and will aid in noise reduction. The appeal also raises concerns over diminished view of the park from Temple Blvd, however based on the already approved area for fencing and the foliage in the area, the only way to clearly view the park at this time is from the front sidewalk, which will not be impacted by granting this request. Based on all of these points, the details outlined in the appeal are not relevant to the expansion that is actually in question and makes it clear that the appellant simply intends to fight the daycare on any and all improvements they make.

For many parents returning to the workforce after a maternity leave, the decision of who to leave your child with is one that leads to endless hours of stress. Compounding this with the long waitlist for daycare facilities and lack of

options for parents in our city as it is, it is disappointing to see a high-quality facility that provides care and support to so many families, like Where The Wild Things Grow West, having to jump through hurdles to continue improving upon their facility for our children. West Lethbridge is so fortunate to have this facility for residents and I truly believe that we should be supporting their efforts to continually improve to serve the children of our community.

With all of this in mind, I strongly encourage the Board to take these points into consideration when deliberating the requested extension of the 6ft fence. Where The Wild Things Grow has been very important to me and my family. We would love to see it continue to grow and educate children in their safe and appropriate manner.

I am responding to the Notice to Neighbours related to the request for a waiver for a fence at 250 McMaster Blvd. W.

I am strongly against the proposed waiver for the following reasons:

1. 250 McMaster Blvd is a pie-shaped, corner lot which directly adjoins my property at 246 McMaster Blvd. If you look at the site drawing provided in the Notice to Neighbours you will see that the fence on the north side yard of 250 McMaster is very close to my back deck. Since the approval of the daycare in 2019 I have been subjected to the sounds of screaming children several times throughout the day. Those opposing the original application were criticized for not enjoying the joyful sounds of children playing. Let me assure you, it is not joyful sounds that I am hearing. The noise has been so loud that I have had to retreat from my deck to inside my home. Fencing in additional outdoor space can only increase the noise. I, along with the majority of the neighbourhood, are retired seniors with no children in our home. I expected a peaceful retirement and being able to enjoy my property. Unfortunately, this has not been the case since the daycare has moved in and with the addition of enclosed yard space on the property, it will only get worse.
2. The proposed fencing is not consistent with the ambience of the neighbourhood and, if approved, would be an eyesore. There are no other front yard fences on that portion of McMaster and no fences on Temple Blvd. that obstruct the view of Nicholas Sheran Park.
3. The property was already granted a parking waiver for more than ½ of the required parking which meant parking for their staff and clients was pushed out onto McMaster Blvd. causing an unsightly obstruction of the view of Nicholas Sheran Park. We were assured by the daycare operators that their staff would, for the most part, be walking or carpooling or parking in the Nicholas Sheran Parking lot. We know that has not happened. My late husband and I made the decision to purchase our home based on the view of beautiful Nicholas Sheran Park. That view has now been impeded by daycare parking and the view for others will be impeded by the proposed fencing. ‘
4. The daycare has significantly impacted the use, enjoyment and value of my property on McMaster Blvd., in particular, and has similarly impacted other properties in the neighbourhood. More than 150 people expressed opposition to the initial application to have the daycare business in this low-density residential zoned area. The valid objections were disregarded by the Commission. Unfortunately, the objections that were pointed out to the Commission have come to fruition and the neighbourhood has been significantly negatively impacted. I urge you to not further disadvantage the neighbourhood around this daycare.

At what point is it decided that the granting of waivers has reached a limit? It seems to be a case of the proverbial “give them an inch . . . “ I urge you to stop this.

There seems to be great sympathy that influences decisions related to the daycare property simply because it is a daycare which is a desirable and needed service. I remind you that there are four other daycares within 10-minute walking distance of 250 McMaster. This is a business in a low-density residential zoned neighbourhood and is, without question, a blight on the neighbourhood. Approving this intrusive fence adds further insult to injury and would significantly negatively impact us even more in the enjoyment of our property. I am strongly opposed to granting a waiver for the fence and I urge you to not approve the waiver for the proposed fence.

I am writing as a concerned parent in response to the formal appeal initiated by residents near Where the Wild Things Grow Early Learning Centre at 250 McMaster Blvd West Lethbridge.

After reading through the neighbour's letter, I feel an overwhelming sadness for their lived experiences. I can't imagine how frustrating it must be to work hard serving their communities, choose to retire in our beautiful city, only to feel unable to relax. As the child of recent retirees, all I wish for my parents is to experience happiness and rest. I would like to add that I have always, and continue, to reside adjacent to active and retired LPS, RCMP, and Peace Officers, and their presence helps my family feel safe at home.

Equally, as the parent of two school-aged children, the oldest being Where the Wild Things Grow South alumnus, and the youngest currently attending the West location, I rely on safe and affordable care for my child outside of my home while my husband and I work. Ideally, I would stay at home with my children and form a community of young families where we could provide enriching experiences for growing bodies and developing minds. Unfortunately, the difficult reality is that even with a modest home, 10 year-old paid-off vehicles, and no credit card debt (which does *not* represent the average families in Alberta as 25% struggling to provide meals for their children according to a 2023 CBC News report), both incomes are required to provide our family with housing, healthy meals, reliable transportation, and expenses covered by workplace benefits.

With the introduction of the Alberta Affordability Grant for licensed child care centres in Alberta, it has become increasingly difficult for families to find licensed child care spaces, and several child care centres in Lethbridge have waitlists exceeding 100+ children, which translates to roughly two years of waiting. For example, according to a 2023 [Canadian Survey on the Provision of Child Care Services, 2022 \(statcan.gc.ca\)](#), approximately one million children are enrolled in child care in Canada, and families are still reporting struggles accessing quality child care.

[This July 2020 article](#) hosted by the University of Alberta and written by the Alberta Policy Coalition for Chronic Disease Prevention in 2020 focuses on the urgency for more quality child care centres in Alberta and cites the importance these centres are in impacting future chronic illnesses by providing environments filled with good nutrition, adequate exercise and supporting and reliable caregivers.

In addition, my youngest child was born with profound disability, and the requested outdoor fencing will provide her with more safe spaces for accommodations, giving her more equitable access in a world that is not designed for her existence.

My hope for this neighbourhood community is that a mutual solution can be reached whereby the centre can provide these desperately needed spaces for these beautiful children while the residential owners can feel undisturbed and receive the rest they have worked so hard all their lives to receive. Perhaps a decorative element on the fencing can honour the aesthetic of the neighbourhood while still providing visual privacy for the children? I do not have all the answers, but I am confident that these two sides can amicably discuss solutions together that benefit both sides.

I will be unable to attend the January 11th meeting at City Hall, as I do not have access to child care that can accommodate my child's disabilities, but I am available if there are any questions.

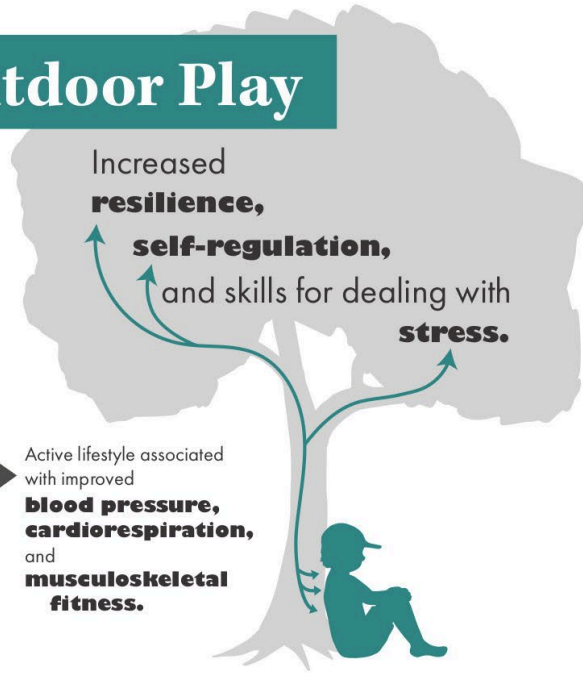

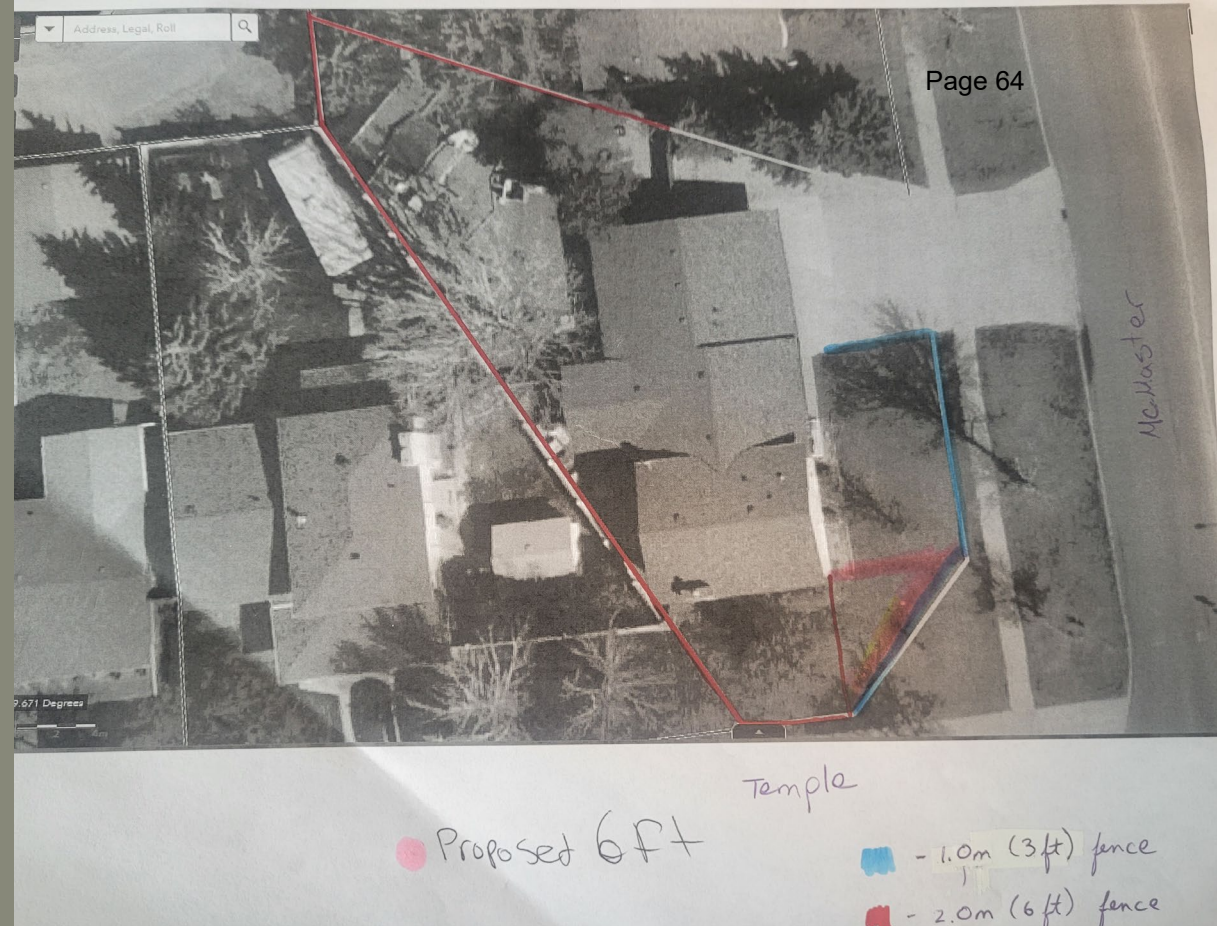

6FT EXTENSION IN AREA OUTLINED IN PINK

We are building a 3ft fence in our front yard and a 6ft fence in our side yard following the current bylaws, we asking for an extension of the 6ft fence (outlined in pink).



Reasons for Request

- It would give additional security and safety to the staff and children of the Program when playing outdoors
- Limit frequency of children crossing the street to use the park
- The extension give more flexibility in how we can maneuver children to the advantage of the neighbourhood. The 6ft extension in the front would mean that the older group that can have 20 children in the backyard can be split up to reduce noise or moved into another yard away from neighbour's back yards during the day.
- 6ft fences are harder to throw toys over than 3ft fences
- Eliminate chances of older children attempting to climb over the fence
- Provide more privacy for the children and neighbourhood

Childcare Licensing Requirements

There are no requirements from Childcare Licensing about the height a fence must be for children to play outdoors. We are requesting a 6ft fence for our own piece of mind. Rather it is granted does not change the number of children using this yard.

The addition of a fence does not increase our capacity to accept more children nor are we looking to increase our capacity as this would require us to change our zoning altogether which we are not looking to do.

The only requirement is there must be floor space of 2 square meters per infant (under 19 months) and 4.5 square meters of space per any child over 19 months. The area's net space will determine the number of children permitted in the yard.

Traffic and Safety

- We submitted our application to the city prior to ensure our fence met city traffic regulations and didn't impede on sight lines. This intersection is a 3 way stop which ensures all vehicles are at the corner prior to preceding.
- Sight lines are not affected due to our fence being brought in significantly from the sidewalk and boulevard.

Neighbor Concerns

Anytime we have received a complaint or request from the neighbor, we do our best to deal with the issue outlined in a timely manner. Parents can attest to emails being sent reminding rules on parking and receiving a reminder every month in our monthly newsletter. The only requests we have had come from 3 Temple Blvd W.

We go out of our way to shovel our neighbors walks when they have not been shoveled yet and have mowed our neighbor's lawn at 246 McMaster countless times as she is unable both front and back as requested. We also paid for the full fence that was needed as the fence adjoining 246 McMaster was in poor repair and unsafe.

Addressing Concerns Continued

- The earliest we typically use our yard space is 9:30 a.m. (after morning snack) until 11:00 a.m.(Lunch), we don't typically go out from 11:00 a.m. until 2:30 p.m. and then use the yard from 2:30 p.m. to 5:00 p.m. Depending on the weather and the day.
- By adding additional play spaces there is a high likelihood we will be outside reduced hours in the day as we have 4 groups of children, and we will not have to stagger our time to each get our allotted time.
- Increasing our play yards does not make us more likely to apply for a childcare major. Outdoor play space has absolutely nothing to do with this. We will be fencing these areas either way, it is to increase the safety of our children while using this space and to give the neighbors privacy.
- The idea that west care is "over saturated" is an assumptive opinion. I have 165 families on my waiting list eagerly looking for care. We do not have the capacity to open another facility and manage it at the level that we see fit, but the West is certainly not saturated with care. I think the city can attest the waiting lists all around the city.

In terms to the complaints on traffic, the current census shows that the population has increased throughout our city. This includes young families coming to the west side. You can see in our parent letters; a large portion are a short walk from our centre.

I believe our traffic department is more than capable of accessing our roads and what needs to be done as neighborhoods expand.

We can see in the last 4 years, the intersection of Temple and McMaster was assessed and turned into a 3 way stop. Metis was opened and has diverted traffic.



WAIVERS GRANTED

Being Apart of the Solution

We have joined the Nicholas Sheran Community School, school travel planning committee. They are embarking on a joint committee with the City of Lethbridge, Alberta Health Services, the Alberta Motor Association, and parents and staff. We hope by joining this committee we can contribute to providing solutions to creating safer neighborhoods and roadways throughout the neighborhoods equipped for walking, scootering, and biking.

summary

At Where The Wild Things Grow Early Learning Centre Ltd. West, we believe safety is of the utmost importance. We feel by extending our 6ft fence and providing a higher fence we will be able to in turn give the neighbors more privacy, provide safety by keeping children onsite more often, and provide safety by ensuring older children are not able to climb a 3 ft fence.

Allowing them to have greater access to safe outdoor play space does not mean that more childcare spots are available. It simply means the children who already attend the centre can be distributed in better ratios throughout the yard.

To those who are bothered, did you forget what it's like to be a parent?

It hurts to know that members in our community do not value my child's right to take up space; to make noise; to feel safe.

The daycare shortage proves that the market is not saturated. Rather, the opposite. There are hundreds of families in Lethbridge who are longing for access to childcare. Neighborhoods are meant to be full of boisterous laughter with toys clanging and banging. It may not be peaceful, but it is full. Full of life, full of new faces, full of hope for the future.

Please consider the sense of community you are creating. It is truly shaping the future of Lethbridge.

- 8) I believe we need to give flexibility to facilities such as childcare centres to make their facilities as optimal as possible for the experience of the kids and staff. There is a severe childcare shortage in Lethbridge from talking to many of my friends who also have kids. Neighbours and citizens need to understand that if we don't make accommodations for childcare centers, it is going to have a severe impact on our city and community. I understand there could be minor inconveniences to some with a 6-foot fence. However, these inconveniences are extremely minor compared to doing everything we can to support childcare centers who service our community. 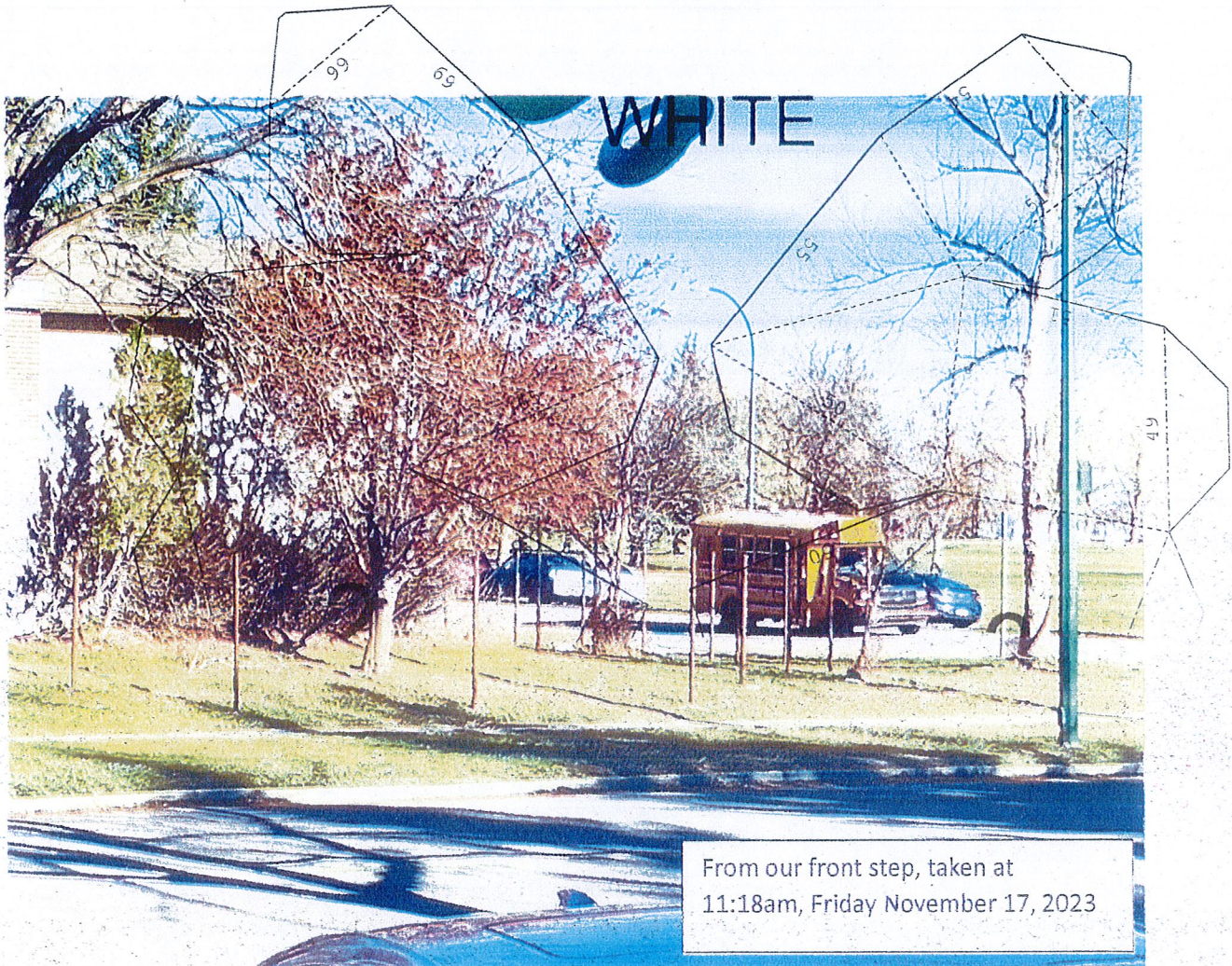
