Bylaw Review

- Removed Benefit
- Any definitions that exist in the MGA, use that definition
- Undeveloped Land
 - Green field
 - Only ever been farmed
 - o Eldorado
 - Servicing is almost impossible to connect to
 - Doesn't draw on services
 - Broadcast Business Park
 - Services are available near by
 - Gave a credit for the existing building
 - Remaining land was essentially greenfield and hadn't previously paid levies
 - o Mountain Minerals
 - Has building, some services
 - Bigger in scale than the legacy lot
 - Subdivision of a legacy lot in the middle of the City
 - Services are in place, no service upgrades are required
 - o If you pay offsite levies, is the levy responsible to get services to the site?
 - Do we need language around "redevelopment"?
 - Do we need to consider only charging certain elements if servicing one type is impossible (i.e. sewer for Eldorado)?
 - Would a decision tree be better than a definition?
 - Byron will take this away and look into how better to describe it. We need to make sure if we define it in the Methodology document, how do we give that status in the Bylaw?
